- (3) Learn the purpose of processing your personal data and whether they are used in accordance with their purpose,

- (5) Request correction of your personal data if it is incomplete or incorrectly processed and request notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- (6) Request the deletion, destruction, or anonymization of your personal data in case the reasons requiring the processing of your personal data disappear, although it has been processed in accordance with the provisions of Law No. 6698 and other relevant laws, and request notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- (7) Object to the emergence of a result against you by analyzing the processed data exclusively through automated systems,
- (8) Request compensation for the damage in case you suffer damage due to the unlawful processing of your personal data.

Our company will conclude your application as soon as possible and within thirty (30) days at the latest, depending on the nature of the request, based on Article 13 of Law No. 6698.

**2. Application Method**

You can submit your requests within the scope of these rights in writing or by using your registered electronic mail (KEP) address, secure electronic signature, mobile signature, or your electronic mail address previously notified to our Company and registered in our system, in accordance with Article 13 of Law No. 6698 and Article 5 of the Communiqué on the Procedures and Principles of Application to the Data Controller.,
